The order for appointment of the interim resolution professional has been passed by the NCLT, Mumbai Bench on March 12, 2018, but the same has been issued and uploaded on the website of the NCLT and made available to the interim resolution professional on March 14, 2018. Notice is hereby given that the National Company Law Tribunal has ordered the commencement of a corporate insolvency resolution process against Aircel Limited on March 12, 2018.

The creditors of Aircel Limited, are hereby called upon to submit a proof of their claims on or before March 28, 2018 to the interim resolution professional at the correspondence address mentioned against item 8.

The financial creditors shall submit their proof of claims by electronic means only. All other creditors may submit the proof of claims in person, by post or by electronic means.

The submission of proof of claims should be made in accordance with Chapter IV of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 ("CIRP Regulations"). The proof of claims is to be submitted by way of the following specified forms in the CIRP Regulations

- Form B- for Claims by Operational Creditors
- Form C- for Claims by Financial Creditors
- Form D- for Claims by Workmen and Employees
- Form E - for Claims by Authorized Representative of Workmen & Employees
- Form F - for Claims by Creditors (Other than Financial Creditors and Operational Creditors)
